This scheme of delegation sets out the Connect Education Trust Partnership's approach to the delegations between the different layers of governance and leadership. It is divided into four sections:

- Strategy and Leadership
- Education and Curriculum
- Financial
- HR and Operations

This scheme of delegation has been prepared using the RASCI responsibility matrix. In the table below, the letters used have the corresponding meanings.

R	means Responsible . The individual/group that has responsibility for undertaking or completing the task delegated to them and reporting on its delivery at suitable intervals. In the case of the CEO, this reporting will be at board level. In the case of the Headteacher, this will be at Academy LGB level.
А	means Accountable . The individual/group that has the ultimate or final responsibility for ensuring completion of the task. This will include determining how the MAT and/or academies (as appropriate) should undertake the task, including determining appropriate milestones and targets to be reported against.
S	means Support . The individual/group who should provide support during the implementation of the task.
С	means Consult . The individual/group that should be consulted as part of the process of the completing the task because they can provide valuable advice and/or input.
1	means Inform. The individual/group that should be kept up-to-date about the progress of the task and/or the decisions in the task.

Points to note:

- In legal terms the schools are academies but the ethos of the Trust is to describe them as schools
- The role of the Members if included in the document Connect Education Trust Roles within the Trust
- The term Headteacher can include the role of the Executive Headteacher or Head of School depending on the school organisational structure
